Mantai Salt Ltd. (MSL) has long history in salt production in Sri Lanka. It manufactured common salt and distribute in the form of Iodated salt, crushed salt, industrial salt, in our country.

#### **Vision Statement**

In keeping with the nature of the business the company has the following vision.

"Development of salt - based enterprises in the North and East by exploration of natural resources connected with chemical and other processes and thereby upgrades the living of the people".

### **Mission Statement**

The Mission of the company is as follows.

"Operation of Salterns, manufacture, processing and marketing of salt and byproducts in the North and Eastern Region".

### Mannar Saltern

Total extent of Mannar Saltern is 240 acres of which 110 acres were in production area up to 2010. 53 acres were developed in 2011 with the financial assistance from the Ministry of Industry and Commerce and now the total production area is 163 acres. Annual salt production is 4500 MT approximately, which is 2.6% of total salt production in SriLanka. This market share of 2.6% will be increased to 5% after further development of Mannar Saltern in near future.

As it is being a profit making organization it manages to do some development and maintenance activities along with staff salaries and welfare through the profit. Meanwhile the organization is depending on government and other donors to do major development & investment activities.

### Chemmani Saltern

The total extent of Chemmani Saltern is 200 acres of which 80 acres are used for salt manufacture. The production activities were carried out with using the available resources. The production staff of Chemmani Saltern used their maximum efforts on salt production for last several years, but expected quantity of salt could not be produced due to poor soil condition and lack of obtaining sufficient quality sea Braine and also fresh water seepage from adjourning land.

Since Saltern have been running at a lost for several years due to low productivity, salt production from this area has been suspended from the year 2012.

### Development

100% of the development work has been completed with utilizing 25 MN under the development project of 25 MN allocated by Treasury.

### Iodated Salt in 1 KG Packet

Production and distribution of iodated salt in 1 Kg laminated packet under the brand name of "Raja Salt" was established and reached the target of 50,000 packets per month and demand is increasing.

### Quality

The institution is certified by the SriLanka Standard Institution to ensure the quality. And also the company is being audited by the authorized auditors nominated by the treasury.

#### **Finance**

This organization is a profit earning company and it is generating the finance by production and sales of common salt and it is managed by its own funds with providing reasonable dividends to the Treasury.

### **Future Plan**

- For the time being the Mannar saltern is selling the iodized crust salt as a major component, but the market trend is now changing toward the table salt (powder salt), so it is being a vital to cater the market demand to ensure company sustainability. Therefore the company is in the process of establishing the iodizing table salt plant ( the output is 2 ton per hour) in Mannar. Our proposal for plant consists of wet-mill, an elutriator, centrifuge, iodizing unit, drier, table salt silos and packeting machine in pouches. Tender is being called and the supplier's documents are under the process of assessment by the technical committee.
- Though the company managed to develop its production side it is struggling to
  develop the infrastructure for its administrative complex. The head office still
  located in the rented building, The Mannar office building constructed in 1940 and
  it is subject to demolish. So there is an instant need for the office building in
  Mannar.
- The currently running crystal salt Iodine mixing plant is donated by UNDP in 2004 and it is subject to replace with the new machine to maintain SriLanka Standard Institute's requirement.

After the development of the table salt plant and with the projected target from 4500 MT to 6000 MT the marketing activities should be improved. The board now in the process of appointing a Marketing officer that will give an emergent need for the vehicle to use for marketing and administrative purpose.

#### **MESSAGE FROM THE GENERAL MANAGER**

It is a great opportunity to express my message in the occasion of Annual General Meeting that Mantai Salt Ltd. carried out its activities, functions progressively and achieved the following results during the period from 1st April 2013 to 31st March, 2014.

#### **OVERVIEW**

Manufactured 4653.28 MT of salt for the year 2013/2014 against the budgeted quantity of 5500 MT and 4498.47 MT of salt was sold in the form of iodated salt 1 Kg packets, industrial salt & crushed salt and the total net turnover for the year is Rs 46.3 Million. Actual profit before taxation for this year Rs 9,690,548.00 as per accounts prepared.

#### Mannar Saltern

Total extent of Mannar Saltern is 240 acres of which 110 acres is in production area up to 2010. 53 acres were developed in 2011 and now the present total production area is 163 acres. Average salt production before development was 4000 MT. Which is 2.6% of total salt production in Sri Lanka. But in 2013/14 the production rate came 4653.28 MT against to the target of 5500 MT. it is decided to increase the target for 6000MT in 2014/15.

#### Chemmani Saltern

The total extent of Chemmani Saltern is 200 acres of which 80 acres are used for salt manufacture. The production activities were carried out with using the available resources. The production staff of Chemmani Saltern used their maximum efforts on salt production for last several years, but expected quantity of salt could not be produced due to poor soil condition and lack of obtaining sufficient quality sea brain and also fresh water seepage from adjourning land. Therefor the production process is temporarily suspended until further analysis done.

Mantai salt is phasing problem of the penetration of competitors from other parts of the Island. To overcome this issue Mantai salt strategically increased its production capacity and reduced the cost of production. As a second strategy the company now moving to inbuilt the table salt plant (2TPH) to make

powder salt and to increase its supply area specially the food production industries in the western part of the country.

The respective ministries, board members, dedicated staffs are in the move to face the challenge and to succeed.

I would happy to thank at this moment to all the stakeholders and well-wishers who helping us in the company development.
